#### TOWN OF GENESEE LIQUOR LICENSE HEARING MINUTES June 12, 2023

Chairman Leair called the meeting to order at 5:30 p.m. Present were Chairman Leair, Town Board Supervisors Morris, Ross, Houston and Braun. Also present were Administrator/ Planner Herrmann, Public Works Superintendent Berg, and Clerk Majeskie.

Chairman Leair read the standard conditions for all licenses and the additional conditions for some of the establishments. Chairman Leair then opened up the floor for any comments. She asked three times. No comments from the floor. The discussion was brought back to the table and the meeting continued.

#### All establishments have these standard conditions for their Liquor License

Noise from patrons, entertainment and devices shall be kept at a reasonable level. Any time a written complaint is received by the Town the owner shall be notified by the Town within 10 days with a copy of the complaint. If licensee shall fail to comply, or shall violate any of the above restrictions and conditions, the Town Board may, by resolution, revoke or suspend this license after a revocation hearing and upon due notice to licensee and a determination by the Town Board on the of revocation.

# The following establishments have additional conditions for their Liquor Licenses

# Vittles and Vine – Hwy. 83

Additional condition that all consumption of alcoholic beverages on the deck/gazebo and patio area shall cease at 10:00 p.m. Sunday -Thursday and at 10:30 p.m. on Friday and Saturday

#### <u>Ella's Public House – Highway 18</u>

Additional conditions alcohol may be served during regular team games and tournaments, with no consumption after 11:00 p.m. in the volleyball area sold by licensed Ella's Public house bartenders only, from the container east of Mickle Road. Subject to site plan and plan of operations being approved by the Town of Genesee Plan Commission. Alcoholic beverages covered under this license may be transported from the main building to the volleyball area.

## InCahoots and Co. - Highway 83

Additional conditions that the outside area on the east side of the building hours is Sunday-Thursday outside hours until 10 p.m. Friday & Saturday outside hours to 10:30 p.m.

## **Cornerstone Restaurant- Highway 83**

Additional conditions Outside seating -Limit of one drink per chair, two per table at one time. Customers must be seated to have a drink

It can be revoked or not renewed. Vittles and Vine has been closed since November 2022. Chairman Leair asked Kristina Verzi why she is not open? Verzi said they experienced extreme staffing issues, inflation and food costs. They decided that they needed to take a step back and look at their business again and regroup. They took the winter to regroup to figure out a new game plan. We are hoping that this is our next step. Houston asked how long is this pause going to last? When do you expect to reopen? Verzi said after the approval it should be 60 days, 90 days just enough time to get all the permits reissued with the County. Chairman Leair you still have the old license and you could be open right now. A seven-month shut down is not a good idea. What is your game plan? The license belongs to the Town and we want it used by an open business. Verzi replied that they have been looking at the restaurant industry and are going to be revamping menus and making things easier for the wait staff. Looking at what fits the community. The game plan is regrouping and becoming more efficient and reaching out to the service industry. Why haven't we been open. I can't make a commitment until I know that I will have a liquor license. Chairman Leair said you have been closed for seven months you should have gotten yourself organized and reopened. Houston said I need a definite date when you're going to be open. The Board discussed the license. Braun made a motion to approve the license for Vittles and Vine with the condition that they open within 60 days, seconded by Ross. The motion passed unanimously. This will be put on the September 11, 2023 agenda to be reviewed by the Board.
