TOWN OF GENESEE MINUTES REGULAR TOWN BOARD MEETING JULY 8, 2024

Chairman Leair called the meeting to order at 6:00 p.m. Present were Chairman Leair, Town Board Supervisors Ross, Morris, Braun and Tesch. Also Present were Administrator/Planner Herrmann, Public Works Superintendent Berg, Clerk Treasurer Majeskie.

<u>Discussion/Action – Request for a Temporary Class "B" Beer license for The Waukesha Fire Fighters Charity for August 17,2024 at Sunset Park to sell beer at the shelter and to allow the consumption of Beer in the Park during the one-day Tournament and authorizing underage persons to be on the premise for which the license is issued.</u>

Ross made a motion to approve the temporary license, seconded by Braun. The motion passed unanimously.

<u>Discussion/Action</u> - Final Plat for Cardinal Court. The property is described as a part of the NE $\frac{1}{4}$ of Section 13, T6N R18E. (GNT 1489-982-008)

<u>Discussion/Action – Request for approval of Pop-Up-Beer Garden at Retzer Nature</u> <u>Center between Raised Grain Brewing Co and Waukesha County Parks</u>

Morris made a motion to approve the final plat subject to the planners' recommendations dated June 21, 2024 and our Town attorney making some small changes and reviewing the developer's agreement, seconded by Braun. The motion passed unanimously.

Discussion/Action – Review of the Parks with Michaelis, Hettwer and Mickelberg

The foundation and floors are in for the new bathrooms at Sunset Park. It should be done by fall. For the five-year plan they are proposing using more of the unused land at Sunset Park with some cut and mowed trails, disk golf, and connecting with the state trails. One of the buildings floods and needs to have rain gutter put on it.
