MESSAGE FROM THE CHAIRMAN

Wisconsin State Budget

There were some benefits for Town government in the latest State Budget which was the result of a bipartisan effort to address relatively stagnant shared revenue for the last 20 years. The new funding dedicates 1 cent of the State's 5 cent sales tax to a local government fund which will benefit all municipalities. That will amount to \$1.5 billion annually to fund new and existing programs, including existing County and Municipal Aids (\$753 million), New Supplemental County and Municipal Aids (\$275 million) and repeal and backfill of the Personal Property Tax (\$174 million). County and Municipal aids (shared revenue) will grow at the rate of State sales tax growth. Beginning July 2024, Genesee stands to receive a \$188,000 increase. The Local Road Improvement Program (LRIP) gained 4% increase each year of the biennium for both the entitlement and discretionary programs, \$1.6 million of this for Towns. The LRIP-S program, which is a supplemental grant program for roads, will have \$100 million one-time funding. We are grateful for the increases for sure, but were disappointed that the Governor vetoed the per mile increase in GTA for towns. The Legislature sent a bill to the Governor that increased the General Transportation Aids block of money by 2% and increased the rate per mile by 2% in each year of the biennium. This would have amounted to an increase from \$2,734 to \$2,789 per mile for calendar year 2024 and to \$2,845 for calendar year 2025 for Genesee's 81 miles of road. Our Wisconsin Towns Association lobbyists still did a great job at getting us where we are today.

Lake Country Fire and Rescue

Due to a lack of staffing the City of Delafield station had to be shut down about half the time over the last few weeks. The LCFR Fire Board unanimously approved a staffing plan which hired on new people in 2023 and provided for 6 new hires in 2024 to address this staffing shortage. All of our seven communities must agree on a budget. Towns of Genesee and Delafield, Villages of Chenequa, Nashotah, Oconomowoc Lake and Wales all agreed on the new staffing plan. The Delafield City Council did not despite the fact that their Fire Board members voted for it. The City would like to see a change in the formula (calculation which determines percentage each community pays) before they agree to anything else. We are only 2 years into a seven-year contract and at least at this early stage, our six communities did not feel inclined to change the formula under which we all joined and which we all agreed is equitable. A change in the formula would significantly increase cost to our residents. At the time of this writing and due to the City's unwillingness to approve the proposed staffing plan, we are still negotiating a budget for 2024. Unfortunately, if a budget is not approved by all 7 communities, the contract indicates that the budget for 2023 would apply, which will be less than is needed to maintain existing staff.

A LITTLE BIT OF LOCAL HISTORY- TEN CHIMNEYS

Ten Chimneys, the home of the late theatre greats Alfred Lunt and Lynn Fontanne, is one of Wisconsin's 44 National Landmarks. This year July 31, 2023, celebrates its 20th year designation as a National Historic Landmark. Even though we share this historic landmark with the world, the residents of the Town of Genesee can be very proud that it is also an integral part of their own local history. Alfred Lunt spent some of his youth in Genesee Depot and often took the passenger train from Genesee Depot into Waukesha where he attended Carroll College Academy, now Carroll University. Alfred loved the area so much during his youth that he later came back and purchased the property on which Ten Chimneys is located.

I grew up in Genesee Depot and have lived less than a half mile from Ten Chimneys most of my life. When I was a child, everyone in the neighborhood knew Ben Perkins, the custodian at Ten Chimneys and his wife, Gert, a beautician who often did Lynn Fontanne's hair. We knew his nephew, who occasionally served as a waiter when dignitaries of the stage and screen visited the estate. The rest of the time he was just an ordinary kid like the rest of us. We knew the neighbors who occasionally worked at the Lunt residence. Lynn often took a stroll on the country road past our farm and Alfred could be found shopping at the local grocery store in Genesee Depot or stopping in at the post office for his mail and perhaps a short chat. When Town meetings used to be held in what is now the Lions Club, I once observed Alfred and Lynn sitting in the back row at a town meeting presided over by my Dad, Larry Bartell, then Genesee Town Chairman. It surely didn't seem that unusual or important to me at the time. Most of us never had an opportunity to see a Broadway play or relate to the New York theatre scene. As a matter of fact, many of us may not have fully realized the importance of the Lunt's celebrity until we became adults.

Many of the celebrities of the day, Noel Coward, Orson Welles, Laurence Olivia, Vivian Leigh, Helen Hayes, Van Johnson, Hugh O'Brien, Carol Channing and others visited Ten Chimneys. We knew they were all stars but a chance meeting would never have moved the locals to ask for an autograph – that would have been a violation of their privacy. It would have been an affront on the Lunt's opportunity to entertain their friends without the worry of them being hounded by their fans. It was our unspoken responsibility to assist in maintaining their privacy. Those days are certainly over. I now take pride in showing visitors where the First Couple of the Theatre once resided and where their memories will live on because of the dedication and hard work of the late Joseph Garton in saving the estate from destruction and those who have continued his legacy. Now today's stars of theatre and television spend a few days every year at Ten Chimneys sharing their skill and talent with others in the industry.

I will gladly show you the beautiful visitor's center and Alfred Lunt and Lynn Fontanne's Ten Chimneys home restored in all its glory to look as though they have never left. I will encourage you to visit and to learn about the contributions the Lunts made to the world of theatre, how their work will continue to inspire all of us, especially those interested in a career in theatre arts.

The name "Genesee" is derived from the Seneca Native American language meaning "the beautiful valley". Come to Ten Chimneys and you will realize why Lynn and Alfred loved this place of beauty in the Kettle Moraine called Genesee Depot.



MEMORIAL DAY COMMEMORATION- GENESEE TOWN PARK- MAY 28, 2023



Memorial Day Speech By Sharon L. Leair, Town Chairman

A sincere thank you to the Miller Bralick VFW Post 5270 for hosting this event each year. Also to any veterans who are here today, thank you for your service.

We set aside this day to remember and honor the brave men and women who have served and sacrificed their lives for our country in all wars. On a day like this, we sometimes speak in generalities, perhaps not realizing the true toll of human life. According to the Department of Defense and Department of Veterans Affairs, more than 1.1 million Americans have been killed in all U.S. wars, just under half of them during the Civil War, after which this day was established. There are 22 U.S. War cemeteries and 32 National Cemeteries on foreign soil where so many of our patriots died. Wisconsin has three cemeteries dedicated to our soldiers: Forest Hill Cemetery Soldiers Lot in Madison, Forest Home Cemetery Soldiers Lot in Milwaukee and Wood National Cemetery in Milwaukee.

320,000 Wisconsin soldiers served during WWII; 8,000 of them died. Wisconsin has lost soldiers in every major war. There are over 58,000 names of those killed or missing in action listed on the Vietnam Veterans Memorial Wall in Washington DC. 1163 of those names represent our fellow Wisconsinites lost from 71 of our 72 Wisconsin Counties during that war alone. And let's not forget those who come home but whose lives are changed forever, some taking their own lives because of the trauma they have experienced. They, too, are casualties of war. Those who enter military service turn their lives over to the United States government and know in doing so they may be asked to fight or even die for our country and many have paid the ultimate price. We honor their courage and selflessness in the face of danger, a testament to the power of their patriotism and love for their country. We remember their families, friends and loved ones left behind. So today as we remember and honor all who were lost in every war in which they represented our country, let's be thankful to them as we enjoy this beautiful day and recognize their sacrifice in defense of our democracy and the freedoms they fought so gallantly to preserve.

DEPARTMENT OF PUBLIC WORKS UPDATE

Public Works Superintendent Berg



DPW is continuing to clear right of ways. This means mowing, brush clearing, tree trimming, and cleaning out ditches. We've been working on opening up intersections for visibility. Our idea behind brushing these days is to be more comprehensive. Instead of trimming the tops of the vegetation, we cut it at the ground. This way it can't grow out over the road and will be easier to manage. Many of the problems at intersections occur where a Town road ends onto a county highway. This is technically in the County's right of way. However, due to a heavy work load, they haven't been able to stay on top of these areas. The Town has done some of them when we can, but we have our own roads to care for. We do appreciate residents making us aware of these issues on all Genesee roads.

We will continue brushing and tree removal throughout winter as this is the best time to do so with the vegetation at a minimum. As always, if there are areas of overgrowth, low hanging branches, trees down, trees or branches that look like they are going to fall, contact Genesee DPW directly at 262-888-2805. We will get there as soon as we can, and if a tree has fallen, we will take care of it right away.

BRUSH DROP OFF

In the Genesee Town Hall Parking lot on November 11, 2023 from 8am to 11am

- Brush and branches no more than 4 inches in diameter
 - Four feet in length or less
 - Tied in bundles no heavier than 70 pounds
- *When Christmas is over John's will pick up Christmas trees on Saturday January 13th 2024 or you can call John's Disposal, 262-473-4700, to have them pick up your tree on one of your bulk pick up days.

Household Battery Recycling

Batteries power many items we use in our daily lives, and can pile up when they are no longer useful. This guide provides an overview of requirements and explains how to safely store and dispose of common types of household batteries.

Battery recycling requirements for households

Wisconsin has no legal requirements, with the exception of lead-acid batteries, for disposal of household-generated batteries. These include alkaline, lithium, lithium ion, metal hydride, nickel-cadmium, silver oxide and zinc-air. Batteries come in many sizes and can be rechargeable or single use. The Department of Natural Resources recommends recycling many battery types by taking them to a drop-off site. Batteries should never go in household recycling bins. For more information, review the chart on the back of this publication, or go to dnr.wi.gov and search "batteries."



Household battery recycling locations

Lead-acid batteries, or "automotive type batteries," are banned from disposal. Consumers may bring lead-acid batteries to any Wisconsin retailer that sells these batteries for recycling. This service is free to customers who buy a new battery. Customers may be charged a fee if they bring in a used battery without buying a new one.

For drop-off locations that accept **other battery types**, visit WisconsinRecyclingDirectory.com or Call2Recycle.org or contact your local recycling program. Some sites may charge a fee or accept only certain battery types.

Know the risk: how to prepare and store batteries for recycling

Many batteries, especially lithium ion, pose a fire risk due to their chemistries and ability to hold a charge. Batteries can spark and start a fire if their terminals touch metal or each other. The following recommendations can lower the risk of fire.

- Put each battery in an individual, clear plastic bag, or tape each battery's terminals with clear packing tape.
- Store batteries in a non-metal container.
- Store swollen or damaged batteries in sand or kitty litter.
- Keep battery labels visible.
- Take stored batteries to a drop-off location frequently.



Single-use alkaline batteries have little recycling value and may be safely thrown in the trash.

Household battery disposal options

The chart below categorizes household-generated battery disposal options by battery type. The battery types listed under "Recycling Encouraged" may be thrown in the trash if recycling is not a viable option. Follow the safety instructions on the front page to reduce the risk of fire in your trash.

ELECTIONS 2024

2024 is a Presidential Election year, which means you will soon be finding voter registration forms and absentee ballot request forms in your mailbox. These mailings are not from your municipal clerk, even though they may appear to be. They are sent by special interest groups and the prefilled voter information on the forms is often outrageously inaccurate. The fastest and easiest way to verify you are registered, the information is accurate, or request your absentee ballots, is to visit myvote.wi.gov

Registration Online is Easy! Search for your record by entering your name and date of birth. Then click the "Update Name or Update Address" tab! Answer a few questions when you are prompted and myvote will provide you with the step by step instructions to get your registration completed fast and conveniently, right from home. Tip: Do not put any spaces or periods in your street address numbers, example – S43W31391 State Road 83

If you have moved or experienced a change in name, or if you find information that is not accurate, you may update your registration online if your Wisconsin driver's license or state ID is current. Keeping your voter registration current saves you time at the polls on Election Day!

If you feel you will need to request an absentee ballot please do so early to be sure you allow enough time for the ballot to be sent to you and returned to the town BEFORE election day. Also make sure all information is filled out on your absentee ballot envelope prior to mailing back. You can also make your request for the absentee ballot on myvote.wi.gov. When making a request for Calendar Year Absentee Ballots be sure to wait until after January 1st 2024.
